Membership Terms and Conditions

Effective from 5th Feb 2026

EFFECT OF THESE CONDITIONS

Any application for, or renewal of, Membership of Lanarkshire Boss Mums Network (LBMN) will be deemed to be made on the basis of these Terms and Conditions, which will govern the on-going relationship between the Member and Lanarkshire Boss Mums Network.

MEMBERSHIP FEES

Your Fee includes;

- The organisation, administration and management of your membership.
- Access to the Lanarkshire Boss Mums Network Portal, an online software platform, supporting you to promote your business, and network with your fellow LMBN Members.
- Any communication to LMBN Members via the Portal OR Via our Facebook Group deemed inappropriate/offensive may result in immediate termination of your Membership, and no refund of Fees paid.
- 10% discount on all meetings and events.
- You will have exclusive advertising in the group once week using the #Bossmumclubbenefit
- LMBN will examine every opportunity to promote its members.
- You will get access to free monthly online networking events and workshops.
- Your Business will be listed within our membership directory on the LMBN Website, which will take potential customers/clients direct to your links.
- You can submit a blog post to be shared on the LMBN website and social media pages, helping you to amplify your reach and visibility.

MEMBERSHIP RENEWAL

Monthly Membership Members will be only a monthly auto renew until cancelled via your account on the website. Payment must be received by the renewal date, payment will be taken again 3 days later if declined in order for the Membership to continue. If payment is not received within 7 days of the renewal date the Membership will be automatically terminated.

LMBN reserves the right not to renew a Membership, at their sole discretion.

MEMBERSHIP TERMINATION

If, due to exceptional circumstances, you wish to terminate your membership. Monthly memberships will end one month after the last payment date. After this all benefits of the membership will come to an end. If you are delivering mutually agreed paid training to the group you must be a member until this date.

LMBN is not required to provide a reason to terminate a Membership, should they feel that a Members' contribution is having a detrimental impact on the wider group. If this is the case the membership will end immediately with no refund of that month.

LEAVING THE LBMN MEMBERSHIP

If you do not wish to renew your Membership at the time your renewal is due, please note the following:

1. You will no longer be able to access the LBMN Portal and you will be removed from the members directory.
2. You may be asked to complete a customer satisfaction survey.
3. You may be asked to submit a testimonial about your time as a Member of our organisation.

MEETINGS AND EVENTS

Our Fees reflect the expertise and experience of our CEO in hosting a meeting and creating a supportive environment in which business can flow.

Fees for events may vary and can be found on the LBMN website and are payable on order to book your space.

Refunds will not be made should you be unable to make the event.

If the meeting has to be canceled, you will be entitled to choose a full refund or the chance to attend at a future date.

MEETING AND EVENT ETIQUETTE

It is essential that all members and non members are treated with respect at every meeting and opportunity within our group and at events.

Confidential information must not be disclosed out with the group.

LBMN will not take responsibility for your possessions at a meeting or event.

LBMN MEMBER PORTAL

As a Member of LBMN you will be provided with access to our technology platform, providing you with a chat facility to support your collaborations with your network, and access to our community forum.

LBMN values diverse opinions and in order to maintain a welcoming environment for our community, your participation in it must always be respectful of others. In particular:
